(b) Any person applying for an awning or canopy permit shall, before the permit is granted, file with the Building Official a copy of a liability insurance policy in the amount of \$300,000 minimum personal liability executed by an company authorized to do business in the State of New York and which will name the Village of Cedarhurst as additional insured. This policy is to be renewed each year and a copy forwarded to the Village Hall.
